The functions of land accounting and state cadastre were transferred to the agency, and the functions of ensuring and controlling the efficient use of land were transferred to the Ministry of Agriculture. It is no coincidence that under the new system, the Cadastre Agency was established as part of the Tax Committee. Because there are huge reserves to expand the tax base in this area. Many irrigated lands in the districts, as well as 100,000 buildings and structures are not included in the state reserve. The head of our state noted that the legislation in the field of cadastre and land accounting is outdated, they are written in a complex, incomprehensible way. This has led to corruption. Today, the system must change completely. The main goal is to keep accurate land records and ensure fairness in this regard. If we look at the shortcomings in the field of land accounting and state cadastre today, in 2020 alone, in about 50,000 cases, 11,200 hectares of land were arbitrarily occupied, of which 3,200 hectares were illegally built. 99% of them are irrigated, fertile agricultural lands. In total, 113 districts are losing a lot of reserves due to the lack of accurate calculations of land categories and types. In addition, Uzbekistan has 21 types of state cadastre. However, the forest cadastre data,

which is one of 21 state cadastres with only 50 percent of the data on 9 cadastres, has not been updated since 1987. Such shortcomings, in turn, hinder the creation of a comprehensive system of state cadastres. There are also shortcomings in the real estate system. For example, the cadastral value of 340,000 objects has not been determined. Of these, more than 200,000 objects are not taxed. In addition, more than 1 million homes do not have cadastral documents.

**Research method:** The President has adopted a number of normative and legal acts to address many of these shortcomings. On September 7, 2020, the Decree of the President of the Republic of Uzbekistan PF-6061 "On measures to radically improve the system of land accounting and state cadastre" was adopted. In accordance with this Presidential Decree, the Online Geoportal with all the information about the land was launched in Uzbekistan from January 1, 2021. The following information will be included in this online geoportal. all information on land type, contour, boundaries and right holders. In addition, the online geoportal will be integrated into the National Geographic Information System. -correctly presented.

Such large-scale reforms are an important step in the further development of private property in our country, the protection of property, the further development of the system of land accounting and state cadastre. At a time when the world is rapidly evolving, if we do not use land resources wisely and efficiently, if we do not introduce innovative technologies in land use, if we do not create new forms of land ownership, we will be guilty before our conscience and the next generation. Today, in order to use the land efficiently, every leader, from the leader to the ordinary worker, must do his job correctly and honestly.
